## IMPORTANT DETAILS

The PTCAS application will open on June 15<sup>th</sup>.

The first day the application can be submitted is July 1<sup>st</sup>.

**\*Note:** some schools do not start their admissions cycle until July or August so you may not see them as a program choice on the PTCAS application during the month of June.

Record your username and password in a secure and convenient location.

Print your completed application for your records before submitting it to PTCAS. Do not send the printed application via mail.

Make sure to go off each individual program's deadline.

# HELPFUL APPLICATION TIPS

- DO NOT ENTER YOUR COURSEWORK FROM MEMORY—USE YOUR TRANSCRIPTS!
- DO NOT WAIT FOR PTCAS TO RECEIVE ALL MATERIALS BEFORE SUBMITTING YOUR APPLICATION.
- DO NOT WAIT FOR PTCAS TO RECEIVE ALL OF YOUR MATERIALS BEFORE YOU SUBMIT YOUR APPLICATION.
- COMPLETE THE "COLLEGES ATTENDED" SECTION OF THE APPLICATION FIRST. PTCAS CANNOT POST TRANSCRIPTS TO YOUR APPLICATION UNTIL THIS STEP IS DONE.
- [LOGIN](#) TO CHECK STATUS OF YOUR TRANSCRIPTS, REFERENCES, GRE SCORES, and PT Observation forms.
- ARRANGE FOR ALL MATERIALS TO ARRIVE BY THE DEADLINE.
- CHECK YOUR EMAIL DAILY FOR IMPORTANT MESSAGES FROM PTCAS AND PROGRAMS.
- REVIEW YOUR APPLICATION FOR ACCURACY BEFORE SUBMITTING THE APPLICATION.

# BEFORE STARTING THE PTCAS APPLICATION:

PRIOR TO APPLYING YOU WILL WANT TO RESEARCH PROGRAMS YOU WISH TO APPLY TO. STUDENTS USUALLY APPLY TO 6 PROGRAMS.


PAY SPECIAL ATTENTION TO:

- CYCLE DATES AND DEADLINE REQUIREMENTS. IN SOME INSTANCES, THE INDIVIDUAL PROGRAM'S DEADLINE MAY DIFFER FROM THE APPLICATION'S CYCLE DATES.
  - APPLICATION FEES. SOME PROGRAMS MAY HAVE A SUPPLEMENTAL FEE; CONTACT YOUR PROGRAMS TO LEARN IF THEY REQUIRE THIS AND HOW TO PAY IT.

# PTCAS BACKGROUND CHECKS

## OVERVIEW

BACKGROUND CHECKS VARY WIDELY FROM PROGRAM TO PROGRAM. SOME PROGRAMS REQUIRE APPLICANT BACKGROUND CHECKS PRIOR TO ACCEPTANCE, WHILE OTHERS REQUIRE THESE CHECKS AS A CONDITION OF MATRICULATION. FOR QUESTIONS ABOUT BACKGROUND CHECKS – INCLUDING WHEN IN THE APPLICATION PROCESS THIS MUST BE COMPLETED – CONTACT EACH OF YOUR PROGRAMS DIRECTLY.

BACKGROUND CHECKS REFLECT ALL PRIOR CONVICTIONS, GUILTY PLEAS, CITY ORDINANCE CITATIONS (SUCH AS PUBLIC INTOXICATION), ILLEGAL POSSESSION(S) INCLUDING POSSESSION OF ALCOHOL UNDER THE LEGAL AGE, PAYMENTS OF FINES (INCLUDING THOSE FOR TRAFFIC VIOLATIONS), AND IN SOME CASES, PRIOR RECORDS THOUGHT TO HAVE BEEN EXPUNGED. NOTE THAT IN SOME STATES, COMMON TRAFFIC VIOLATIONS CAN BE CONSIDERED MISDEMEANORS.

## PROGRAMS THAT REQUIRE BACKGROUND CHECKS

PTCAS HAS PARTNERED WITH [CERTIPHI SCREENING](#) TO OFFER PARTICIPATING PROGRAMS THE OPTION OF A NATIONAL CRIMINAL BACKGROUND CHECK (CBC) PROCESS FOR ACCEPTED APPLICANTS. IF YOU RECEIVE AN OFFER OF ADMISSION FROM A CBC PARTICIPATING PROGRAM, CERTIPHI SCREENING WILL EMAIL YOU WITH INSTRUCTIONS ON HOW TO COMPLETE THE BACKGROUND CHECK PROCESS. RECEIPT OF THIS EMAIL INDICATES THAT THE CBC IS REQUIRED AS PART OF YOUR ACCEPTANCE TO THE PROGRAM.

## FEE PAYMENTS

BEFORE A CBC CAN BE COMPLETED, YOU MUST PAY A REQUIRED FEE OF \$77.75 USD, WHICH IS PAYABLE BY CREDIT CARD, DEBIT CARD, OR PAYPAL.



# FEES & FEE WAIVERS

## Fees

PTCAS charges \$170 for the first program you apply to and \$70 for each additional program.

Some programs may have an additional supplemental fee; contact your programs to learn if they require this and how to pay it.

## Fee Assistance Program

Beginning at the start of the cycle, a limited number of fee waivers are provided to qualified applicants on a first-come, first-served basis. Each fee waiver covers only the initial application fee, so if you wish to apply to additional programs, you are responsible for the remaining balance. If you received a fee waiver during a previous cycle, you may still apply for another in the next cycle.

You may request a fee waiver as soon as you create an application, but keep in mind that fee waiver funds can be quickly depleted. Contact customer service at [617-612-2040](tel:617-612-2040) before you submit a fee waiver request to determine if waivers are still available.

# FEE WAIVER QUALIFICATION REQUIREMENTS:

To qualify for a fee waiver, you must have either:

- Filed a 2023 Federal Income Tax Return Form 1040 with an adjusted gross income that falls below the Low Income Level listed below, or
- Been listed as a dependent on a filed 2023 Federal Income Tax Return Form 1040 with an adjusted gross income that falls below the Low Income Level (see previous slide). **If you were claimed as a dependent by a parent or guardian on their 2023 Federal Income Tax Return, PTCAS requires you to use that individual's Federal Income Tax Return instead of your own.**

Additionally, you must request a fee waiver **before** you submit your application. Requests received after an application has been submitted will not be honored.

If you are approved for a fee waiver, you are required to submit your application within 14 days (including holidays and weekends). Extensions will not be granted; failure to submit your application on time will void your fee waiver and you will not be allowed to reapply for a waiver.

## Applying for a Fee Waiver

Determine when to apply for your waiver.

Keep in mind that fee waivers are limited and only valid for 14 days (including holidays and weekends) from the time you are approved. Be ready to submit your application if you are approved.

Start your application.

You must have an account to apply for a fee waiver. Fee assistance applications are not accepted by mail or email.

Complete and submit your fee assistance application.

1. Click on your name in the upper right corner of the application, then select **Fee Assistance Program**.
2. Enter your household's adjusted gross income for 2023 and the current number of members in your household. Note that "size of family" includes the number of people claimed as dependents on the tax report.
3. Upload a copy of the filed 2023 Federal Income Tax Return Form 1040. This form was either filed by you or by someone who listed you as a dependent (such as a parent or guardian). You must upload the full tax return form; summary printouts are not accepted. Remember, if you were listed as a dependent, you must submit that individual's tax return form instead of your own.

Await notification.

Once you submit your fee waiver request, it can take up to 10 business days to process. The status of your request will be sent to both your email address and your application inbox.

While your fee waiver request is pending, you are unable to submit your application. To submit your application and forfeit your waiver request, return to the **Fee Assistance Program** section and click **Cancel Request**. Once you submit your application, you are ineligible to apply for another fee waiver.

Submit your application and pay any remaining balance.

If you are approved, the waiver amount of \$170 will be automatically deducted from your total fees, and you are responsible for any remaining balance. Contact customer service immediately if you do not see the waiver amount deducted.

Remember to submit your application within 14 days of your approval (including holidays and weekends). Outstanding transcripts, references, and/or test scores do not have to be received within this timeframe.

# ACCOUNT CREATION

To begin, click the “Create an Account” button on the PTCAS application homepage. Enter a username, password, security question, and valid contact information. Click on the “Create My Account” button to activate a new account and unique PTCAS identification number. You are not permitted to create more than 1 PTCAS account per application cycle! Duplicate accounts will result in significant processing delays and problems with application materials! PTCAS will delete duplicate accounts, including associated documents!

Once you have created an account, you must select at least one PT school or college to which you will be applying. It is best to add all programs you are applying to at this point. You can always add more programs later or remove a program prior to submission of the application if you opt not to apply to this program. After you submit, you can only add new programs---you can NOT delete or substitute program selections. Once you have added one or more programs to which you are applying, you will need to review the list of designations schools and colleges, and then advance to the application. The average applicant applies to 6 programs.

# PTCAS RELEASE STATEMENT

- There are 3 main parts to the Release Statement section. You must review and respond to the following release statements in order to submit your application:

## Pre-submission Release of Information

By answering “yes,” you authorize PTCAS to release your name and contact information to your selected programs before you submit your final application. You are encouraged to select “yes” so that your selected programs can send you important information about their specific admissions processes before you complete your application.

## Advisor Release

Selecting YES allows PTCAS to release certain information to Pre-Health advisors. We encourage you to authorize release, as it is useful to our office in assisting you and future applicants!

## Certification and Authorization statement

Serves as your legal signature, and is binding

# CITIZENSHIP INFORMATION



# TRANSCRIPT ENTRY

There is an optional service that you can choose to use that will enter your transcript coursework for you for a fee. It can take weeks for this to be completed so just keep that in mind. The fees are \$69 for your first 3 transcripts, \$95 if you need to enter 4-6 transcripts, and \$145 for 7 or more transcripts. You can select to have the Professional Transcript Entry done or to enter your coursework yourself for free.

You will start by adding a semester and then adding the courses from that semester.

# PROFESSIONAL TRANSCRIPT ENTRY (PTE) CONTINUED

Fees for PTE are as follows:

- 1-3 transcripts: \$80
- 4-6 transcripts: \$110
- 7 or more transcripts: \$150

These fees apply only to coursework entry and are in addition to regular application fees. Fee waivers and coupon codes are not available for PTE. Additionally, your PTE payment cannot be transferred to another cycle (e.g., re-applicants, applicants applying in multiple cycles, etc.).

## Process

To successfully sign up for PTE, complete the following required steps:

1. Enter any coursework that is **not** eligible for PTE.

Before the PTE process can start, you must enter any coursework that is ineligible for PTE. Ineligible coursework includes planned or in-progress courses and courses taken at unlisted US schools. We cannot enter these courses on your behalf and they must be entered by you before you pay for PTE.

Note that once you make your PTE payment, you will be unable to enter any additional planned/in-progress courses until the verification process is complete.
2. Send us your official transcripts.

We must receive all required transcripts before PTE can begin. See [Sending Official Transcripts to PTCAS](#) for more details. Monitor your application to ensure your transcripts are received. On average, it takes up to five business days from the date we receive your transcripts to post them to your application. Once your transcripts post, you will receive a confirmation email and you can view your transcript receipt dates on the [Check Status](#) tab.
3. Sign up and pay for PTE.


Click [Tell Me More](#) at the bottom of the [Transcript Entry](#) page and follow the prompts to sign up for PTE and enter your payment information. Payments are non-refundable and can only be made online via credit card. After making your payment, you can continue adding colleges attended for PTE until you submit your application. You cannot add any colleges attended for PTE once your application is submitted or during the Academic Update period (if applicable).
4. Submit and complete your application.

Before PTE, you must submit and pay for your application. Once your application is submitted and we receive your transcripts, we will begin work on your application within 10 business days. Note that applications are placed in line for PTE on a first-come, first-served basis.

This standardization is achieved by using your coursework to create a standard set of GPAs, ensuring you are compared to other applicants fairly and equally.
- Complete the **Colleges Attended** section before entering your courses.
- Report all courses on your transcripts, not just prerequisites. Be sure to include courses from which you withdrew, repeated courses, ungraded labs, test credits, gym courses, orientations, or other non-graded courses.
- Use official copies of your transcripts. Coursework must exactly match your official transcripts; don't use an unofficial version, like a printout from your school's website. List your courses under the correct term, year, and class level. Department prefixes and course numbers must precisely match those on your transcripts.
- Enter courses under the institution where you originally took the course, exactly as they appear on the original school's transcript. Don't list courses under the school in which the credits were transferred. You may need to go back to your Colleges Attended and add a school to enter the transfer credits for.

- **FRESHMAN-SENIOR:** APPLIES TO ALL COLLEGE- OR UNIVERSITY-LEVEL COURSES TAKEN PRIOR TO YOUR FIRST BACHELOR'S DEGREE. IN GENERAL, FOUR-YEAR STUDENTS SHOULD LIST ONE YEAR PER DESIGNATION AND FIVE-YEAR STUDENTS SHOULD LIST THEIR LAST TWO YEARS AS SENIOR. NON-TRADITIONAL STUDENTS SHOULD LABEL THEIR TERMS AS EVENLY AS POSSIBLE IN CHRONOLOGICAL ORDER.
    - Dual enrollment courses (college courses taken during high school) are considered Freshman and should be listed under the college where you took them. Do **not** report these courses again as transfer credits at your undergraduate institution.
  - **POST-BACCALAUREATE:** APPLIES TO UNDERGRADUATE LEVEL COURSES TAKEN AFTER YOUR FIRST BACHELOR'S DEGREE IS EARNED. IF YOU EARNED A SECOND BACHELOR'S DEGREE, THAT IS CONSIDERED POST-BACCALAUREATE.
  - **GRADUATE:** APPLIES TO MASTER'S DEGREE- AND DOCTORATE DEGREE-LEVEL WORK ONLY, REGARDLESS OF WHETHER THE DEGREE WAS EARNED. WORK SUCH AS THAT TAKEN IN PURSUIT OF A PH.D, MD, PHARM.D, JD, JURIS.D, LL.D, DC., ETC. ARE CONSIDERED DOCTORATE DEGREE-LEVEL.

# ENTERING COURSES FOR A COMPLETED TERM

1. CLICK **ADD A COURSE** UNDER THE APPROPRIATE TERM.
2. ENTER THE COURSE CODE. DEPARTMENT PREFIXES AND COURSE NUMBERS MUST EXACTLY MATCH WHAT APPEARS ON YOUR OFFICIAL TRANSCRIPT.
3. ENTER THE COURSE TITLE. YOU CAN ABBREVIATE IT IF IT DOES NOT FIT IN THE TEXT BOX.
4. SELECT THE COURSE SUBJECT. IF YOU'RE UNSURE, MAKE YOUR BEST GUESS; OUR TEAM WILL HELP YOU IF IT DOESN'T MATCH.
5. ENTER THE COURSE CREDITS EXACTLY AS THEY APPEAR ON YOUR TRANSCRIPT. SEE THE **COURSE CREDITS** SECTION BELOW FOR MORE DETAILS.
6. ENTER THE GRADE EXACTLY AS IT APPEARS ON YOUR TRANSCRIPT, INCLUDING ANY PLUSES OR MINUSES.
  1. If your grades are listed as "BA," "CB," or "DC," you must list them as "AB," "BC," and "CD" in order for the system to recognize them.
  2. If your grades are listed as numbers (e.g., 93), enter them exactly as they appear on your transcript. They will automatically convert to the equivalent CAS letter grade.

# ENTERING COURSES FOR AN IN-PROGRESS OR PLANNED TERM

YOU SHOULD ENTER ANY COURSES THAT YOU ARE CURRENTLY TAKING OR PLAN TO TAKE SOON. THIS IS NOT REQUIRED, BUT IS STRONGLY RECOMMENDED, AS SOME PROGRAMS REQUIRE IT. NOTE, HOWEVER, THAT ANY TERM CONTAINING IN PROGRESS/PLANNED COURSES CANNOT BE MARKED AS COMPLETE; THE ENTIRE TERM MUST BE MARKED AS IN PROGRESS/PLANNED. CONTACT YOUR PROGRAMS TO DETERMINE IF THEY REQUIRE PLANNED OR IN-PROGRESS COURSEWORK TO BE LISTED. ONCE YOU COMPLETE IN-PROGRESS COURSES, YOU CAN UPDATE THEM IN THE APPLICATION.

  3. ENTER THE COURSE TITLE. YOU CAN ABBREVIATE IT IF IT DOES NOT FIT IN THE TEXT BOX.
  4. SELECT THE COURSE SUBJECT. IF YOU'RE UNSURE, MAKE YOUR BEST GUESS.
  5. ENTER THE EXPECTED COURSE CREDITS. DEPENDING ON THE FORMAT OF YOUR CREDITS, YOU MAY NEED TO CONVERT THEM. SEE THE **COURSE CREDITS** SECTION BELOW FOR MORE DETAILS.
  6. CLICK **SAVE**.
  7. CONTINUE ADDING COURSES, AS NEEDED.

# ENTERING NARRATIVE TRANSCRIPTS

IF YOUR INSTITUTION USES A NARRATIVE TRANSCRIPT, ENTER YOUR COURSEWORK AS DESCRIBED ABOVE. IF THE TRANSCRIPT LISTS "SUGGESTED" CREDITS AND/OR GRADES, BE SURE TO ENTER THOSE AS WELL; OTHERWISE, LIST THE COURSE CREDITS AS "0.0" AND THE GRADES AS "PASS."

YOUR PROGRAMS WILL SEE THE LIST OF CLASSES YOU TOOK, ALONG WITH A COPY OF THE OFFICIAL NARRATIVE TRANSCRIPT THAT YOU SUBMIT.

# COURSE CREDITS

## **SEMESTER, TRIMESTER, AND QUARTER CREDITS**

IF YOUR COURSE CREDITS ARE MOSTLY IN "3.0," "4.0," OR "5.0" FORMAT, THEN YOUR TRANSCRIPT IS LISTING NORMAL SEMESTER, TRIMESTER, OR QUARTER CREDITS AND NO CONVERSION IS NECESSARY. ENTER THE CREDITS EXACTLY AS THEY APPEAR ON YOUR TRANSCRIPT.

## **UNIT CREDITS**

IF ALL OF YOUR COURSE CREDITS ARE LISTED IN "1.0" OR "0.50" FORMAT, THEN YOUR TRANSCRIPT IS LISTING CREDIT UNITS AND YOU NEED TO PERFORM A CONVERSION. CHECK THE BACK OF YOUR TRANSCRIPT FOR A CONVERSION RATIO, WHICH WILL SAY SOMETHING LIKE "1 UNIT IS EQUIVALENT TO 4 SEMESTER HOURS."

IF THERE IS NO CONVERSION ON THE BACK OF YOUR TRANSCRIPT, CONTACT YOUR REGISTRAR'S OFFICE TO DETERMINE THE CONVERSION RATIO. THEN, CONVERT THE CREDITS BY MULTIPLYING THE NUMBER OF UNITS LISTED ON YOUR TRANSCRIPT BY THE CONVERSION FACTOR. FOR EXAMPLE, IF YOUR CONVERSION IS 1 UNIT = 4 HOURS AND YOUR TRANSCRIPT LISTS 1 UNIT FOR A COURSE, YOU WOULD ENTER 4.00 CREDITS ON YOUR APPLICATION. IF 0.50 IS LISTED, YOU WOULD ENTER 2.00.

# COURSE CREDITS CONTINUED

## LAB CREDITS

IF YOUR TRANSCRIPT LISTS LABS SEPARATELY, YOU MUST LIST THEM AS SEPARATE COURSES ON YOUR APPLICATION AS WELL. RECORD THE LABS EXACTLY AS THEY APPEAR ON YOUR TRANSCRIPT. IF YOUR TRANSCRIPT COMBINES LAB AND LECTURE COURSES INTO ONE COURSE, LIST IT AS ONE COURSE ON YOUR APPLICATION.

## TEST CREDITS

YOU CAN ONLY LIST TEST CREDITS IF THEY WERE AWARDED BY ONE OF THE SCHOOLS YOU ATTENDED, AND THEY APPEAR ON YOUR TRANSCRIPT. TEST CREDIT TYPES INCLUDE ADVANCED PLACEMENT (AP), INTERNATIONAL BACCALAUREATE (IB), CLEP, DANTE, REGENTS, AND COURSES YOU "TESTED OUT OF" AT COLLEGE OR UNIVERSITY. LIST THESE CREDITS UNDER YOUR FIRST TERM AT THE SCHOOL THAT AWARDED YOU THE CREDIT AND ENTER "CR" AS THE GRADE. IF NO COURSE PREFIX OR NUMBER APPEARS ON THE TRANSCRIPT, ENTER "N/A" FOR NOT APPLICABLE.

BE SURE TO DESIGNATE THESE TEST CREDITS APPROPRIATELY IN THE TRANSCRIPT REVIEW SECTION (BELOW).

# ENTER COURSE TYPES (TRANSCRIPT REVIEW)

ONCE YOU ENTER AND SAVE ALL YOUR COURSES, CLICK **REVIEW & FINALIZE MY TRANSCRIPTS**. YOUR NEXT STEP IS TO DESIGNATE SPECIFIC COURSES AS STUDY ABROAD, ADVANCED PLACEMENT, REPEATED, ETC. YOU MUST COMPLETE TRANSCRIPT REVIEW BEFORE YOU CAN ADD PREREQUISITES IN THE PROGRAM MATERIALS SECTION.

## PRIMARY COLLEGE

IDENTIFY YOUR PRIMARY UNDERGRADUATE INSTITUTION. THIS IS TYPICALLY CONSIDERED THE COLLEGE OR UNIVERSITY WHERE YOU EARNED (OR WILL EARN) YOUR FIRST BACHELOR'S DEGREE. IF NO DEGREE IS PLANNED, SELECT THE COLLEGE OR UNIVERSITY WHERE YOU COMPLETED THE MAJORITY OF YOUR UNDERGRADUATE COURSEWORK.

## REPEATED CLASSES

INDICATE IF YOU REPEATED ANY OF YOUR COURSES. COURSES SHOULD ONLY BE MARKED AS REPEATED IF YOU REPEATED THEM AT THE SAME INSTITUTION (I.E., YOU RETOOK THE COURSE FOR A HIGHER GRADE). WITHDRAWN COURSES, COURSES TAKEN AT DIFFERENT SCHOOLS, AND COURSES TAKEN MULTIPLE TIMES FOR NEW CREDIT (I.E., SCHOOL BAND, PHYSICAL EDUCATION, ETC) ARE NOT CONSIDERED REPEATED.

RECORD FULL CREDIT VALUES AND GRADES FOR ALL REPEATED COURSES. PTCAS IS REQUIRED TO INCLUDE ALL REPEATED COURSES IN GPA CALCULATIONS, REGARDLESS OF AN INSTITUTION'S OR STATE'S ACADEMIC FORGIVENESS POLICIES.

IF YOU REPEATED COURSES, SELECT **YES** AND CLICK **CONTINUE**. THEN, CLICK THE PLUS SIGN NEXT TO THE REPEATED COURSES FOR EACH COLLEGE OR UNIVERSITY YOU ATTENDED.

IF YOU TOOK HONORS COURSES, SELECT **YES** AND CLICK **CONTINUE**. THEN, CLICK THE PLUS SIGN NEXT TO THE COURSES. BE SURE TO ONLY SELECT COURSES THAT ARE CLEARLY IDENTIFIED AS HONORS ON YOUR TRANSCRIPT.

## STUDY ABROAD COURSES

IF YOU STUDIED ABROAD, INDICATE THE COURSES YOU TOOK AS PART OF YOUR INSTITUTION'S STUDY ABROAD PROGRAM. REFER TO THE SENDING TRANSCRIPTS SECTION FOR MORE INFORMATION.

## TRANSCRIPT ENTRY LAB REVIEW


- After you have entered all your coursework, select Transcript Review. It will prompt you to answer a series of questions and to select the courses that are applicable. For example, you will be asked “Did you take any Lab Courses?”. If you did, click on Yes and then you will be able to add the courses that were labs.

If your transcript lists labs separately, you must list them as separate courses on your application as well. Record the labs exactly as they appear on your transcript. If your transcript combines lab and lecture courses into one course, list it as one course on your application.

# ORDERING TRANSCRIPTS



You need to order OFFICIAL transcripts from EVERY institution that you have attended even if it was for transient courses or dual enrollment, even if your courses transferred to another institution. It can take several weeks for CASAA to receive your transcripts so make sure ordering them is one of the first things you do after you create your account. That way you do not slow down the verification process. UGA uses Parchment. To order your UGA transcripts log into your MyUGA portal and select Order Transcripts. There is a fee.

# STANDARDIZED TESTS

The last section of the Academic History section will collect your standardized test scores. If you do not wish to enter any test information, select the “I Am Not Adding Standardized Tests” button. Many of you will have GRE and/or MCAT. Select all the tests that are applicable to you. We will use the GRE as an example. Select “Add Test Score” under the test title that you would like to include. Then you will be prompted to enter that test’s information. If you have completed the exam, then include your scoring information. If you have not completed the exam, enter the dates that you plan on taking the test.

Note that self-reporting your scores is not the same as providing official scores to your programs.

## Standardized Tests

You can self-report your standardized test scores or report tests you plan to take in this section. Some of the programs you apply to may require you to report certain test scores; be sure to check with your programs to ensure you're completing all requirements. Once you submit your application, you cannot edit previously entered tests, but you can add new tests.

# REFERENCES

References (sometimes called Letters of Evaluation, Letters of Reference, or Letters of Recommendation) are submitted by the references themselves; they cannot be completed or submitted by the applicant or another party on behalf of the reference. Before getting started, consider the following:

- **All references are submitted electronically** by references.

**Research each program's requirements.** You should determine whether your programs have specific requirements regarding reference roles or relationships before listing references on your application. Many programs have strict guidelines and completed references cannot be removed or replaced.

- **Choose your references early in the application process** to ensure they have adequate time to submit your reference.

- **Prepare your references.** Once you choose your references, be sure to inform them about the process and that they will be completing the reference electronically. We recommend getting their preferred email address and asking that they monitor that inbox for your reference request (which will come from [ptcasinfo@ptcas.org](mailto:ptcasinfo@ptcas.org)), including any junk or spam folders.

# THE REFERENCE PROCESS

WHEN YOU REQUEST REFERENCES, YOUR REFERENCE RECEIVES AN EMAIL REQUEST WITH A LINK TO LETTERS BY LIAISON. REFERENCES REVIEW YOUR REQUESTS, AND THEN ACCEPT, COMPLETE, OR DENY THEM. REFERENCES MAY COMPLETE ASSESSMENTS SUCH AS WRITING ESSAYS, COMPLETING LIKERT SCALES, AND/OR UPLOADING LETTERS.

ONCE YOUR REFERENCE COMPLETES YOUR REFERENCE, YOU'LL BE NOTIFIED VIA EMAIL. YOU CAN CHECK THE STATUS OF YOUR REFERENCE REQUESTS IN THE **CHECK STATUS** TAB OF YOUR APPLICATION AT ANY TIME.

## REQUIREMENTS

YOU CAN ENTER INFORMATION FOR A **MAXIMUM OF 4** REFERENCES. IF YOU WANT TO SUBMIT MORE, SEND THOSE ADDITIONAL REFERENCES DIRECTLY TO YOUR PROGRAMS.

## COMMITTEE LETTERS

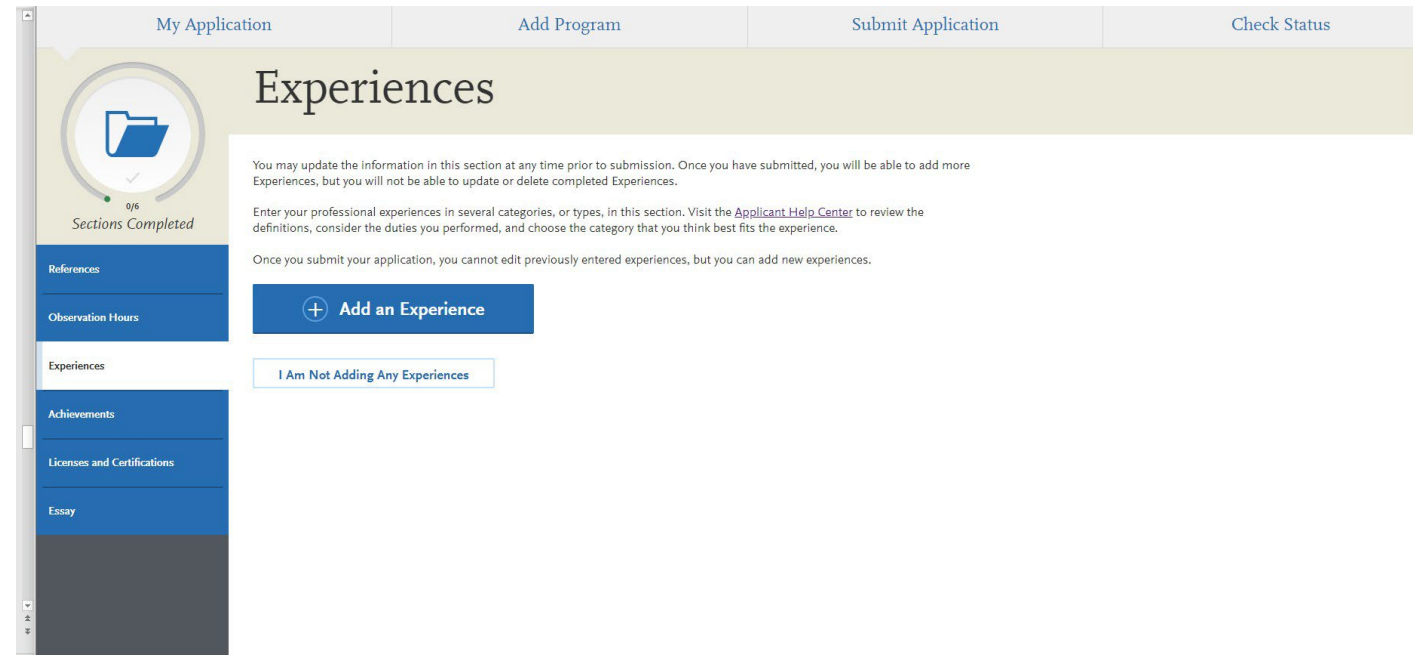

## Employment

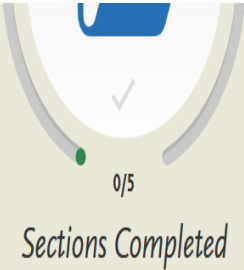

- GSU is **NOT** your first choice. But, is one of the ones you are interested in.

**An application is COMPLETE when:**

- At least (1) set of GRE scores has been received
- Prerequisites have been self-reported/matched within PTCAS
- GSU Graduate application and \$50 application fee have been received - <https://gradapply.gsu.edu/apply/>
- PTCAS application is **complete & verified** and their fee has been received (*all official transcripts rcvd, a minimum of 40 observation hours, and two references included and verified*)
- All official transcripts have been received by PTCAS

TO SUBMIT A KIRA ASSESSMENT:

1. CLICK **OPEN KIRA ASSESSMENT**.
2. YOU WILL THEN BE REDIRECTED TO KIRA TALENT, WHERE YOU CAN REGISTER AND COMPLETE YOUR ASSESSMENT.

ONCE YOU COMPLETE THE KIRA ASSESSMENT, RETURN TO YOUR PTCAS APPLICATION TO VERIFY THAT THE SECTION IS MARKED COMPLETE. IT CAN TAKE UP TO ONE HOUR TO UPDATE, AND YOU MAY NEED TO REFRESH THE PAGE.
