Helpful Application Tips

- Do NOT enter Coursework from memory. Use your transcripts!
- Do NOT wait for OTCAS to receive all materials before clicking submit on your application. Test Scores, Letters of recommendation and transcripts automatically line up!
- OTCAS cannot verify your transcripts until you do the “Colleges Attended” section of the application.
- On the status page post submission make sure you check the status of your test scores, letters of recommendation and transcripts.
- Arrange for all materials to arrive by the school’s deadline. It can take OTCAS up to 10 business days to process your application.
- Review your application for accuracy before submitting it.

Statement of Purpose (General)

Personal Statement

Create and upload a personal statement that responds to the following question:

Explain how your lived experiences (e.g., personal, professional, cultural, etc.) have influenced your interest in pursuing OT.

This essay is an important part of your application and allows you to clearly and effectively express yourself. Do not personalize this essay for a particular program, as it is shared with all your programs.

Requirements

- **Keep your topic general:** Keep the statement general as this essay is sent to all the programs you apply to. If you plan to only apply to one program, we still strongly recommend keeping your statement general in case you later apply to additional programs. Once you submit your application, the essay cannot be edited or changed.
- **Use your own words:** Plagiarizing any part of your essay is a violation of the code of conduct and may subject you to sanctions.

Proofreading

Be sure to read over your essay several times to catch any spelling, grammar, punctuation, etc., errors before submitting. Once you submit your application, you cannot edit your essay. If you find an error after submission that you believe could have major effects on your application, we recommend sending a corrected copy directly to the programs you applied to.

School SOP Prompts

Heads up!

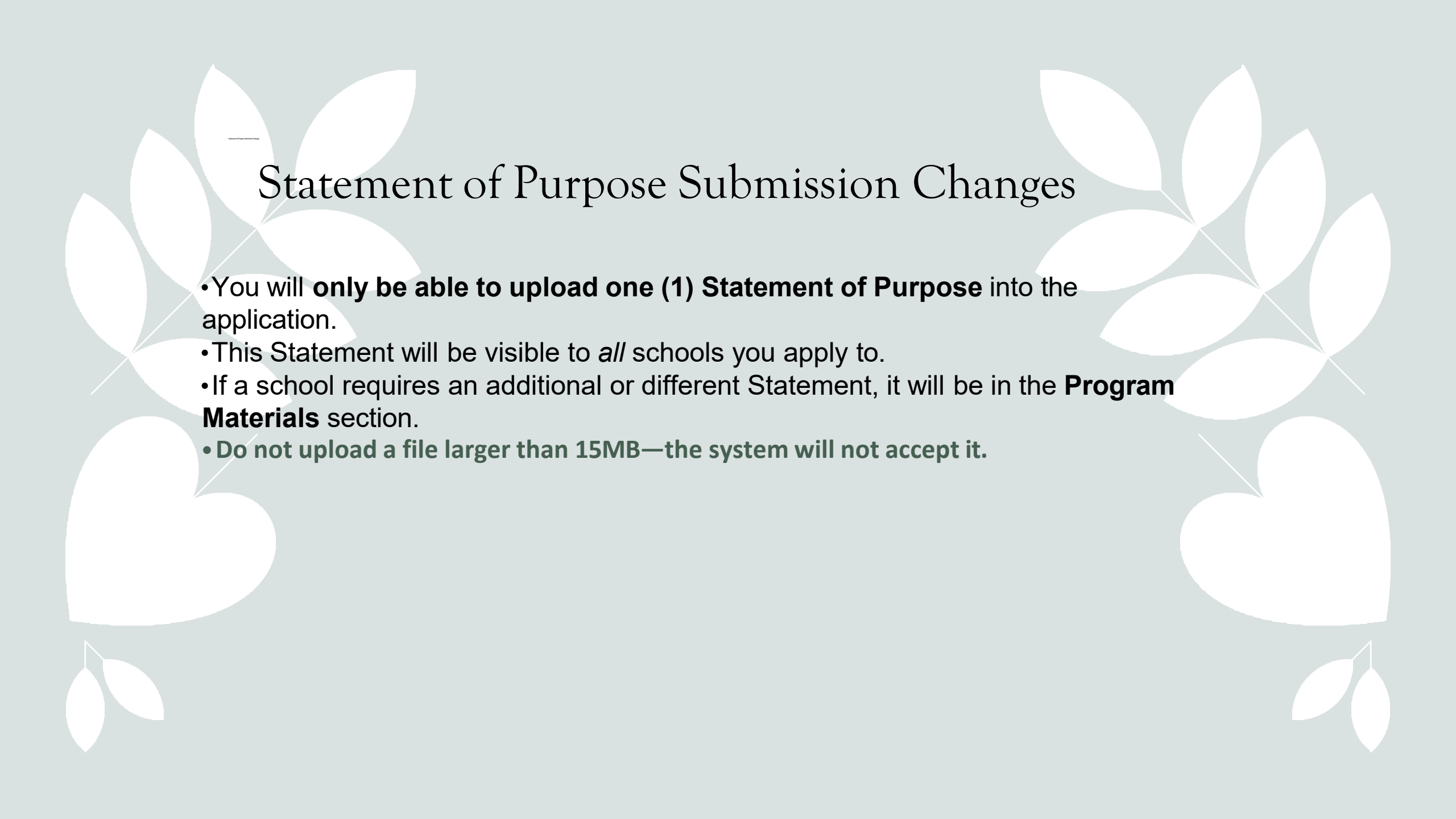
Some schools require their own additional essays or Statements of Purpose (SOPs) beyond what you submit through OTCAS. For example, the MUSC hybrid program and Duke University may have school-specific writing components—make sure to check their admissions pages carefully.

Exciting update:

Mercer University is launching a brand-new Occupational Therapy program starting in 2026, and applications are open in the current cycle! This is a great new option for Georgia-based students.

Before Starting the OTCAS Application

- Pay special attention to cycle dates and your individual program's deadlines. Your individual program may have sooner admission dates than the OTCAS platform.
- Pay special attention to application fees and supplemental applications. Some schools have supplemental applications which will cost extra.
- Pay special attention to evaluation requirements and who counts as a recommender
- Pay special attention to minimum requirements: test scores, prerequisites, recommenders, supplemental applications, etc.



Statement of Purpose Submission Changes

- You will **only be able to upload one (1) Statement of Purpose** into the application.
- This Statement will be visible to *all* schools you apply to.
- If a school requires an additional or different Statement, it will be in the **Program Materials** section.
- **Do not upload a file larger than 15MB—the system will not accept it.**

Etiquette

OTCAS expects all applicants to exhibit professionalism when contacting customer service. Applicants must identify themselves properly and honestly, as information cannot be provided to parents, spouses, family members, or friends. Misrepresentation of identity and/or dishonest, threatening, or offensive communication will not be tolerated.

Fees

- OTCAS charges \$172 for the first program you apply to and \$71 for each additional program.
- Some programs may have an additional supplemental fee; contact your programs to learn if they require this and how to pay it

Fee Waivers

Fee Assistance Program

- Beginning at the start of the cycle, a limited number of fee waivers are provided to qualified applicants on a first-come, first-served basis. Each fee waiver covers only the initial application fee, so if you wish to apply to additional programs, you are responsible for the remaining balance. If you received a fee waiver during a previous cycle, you may still apply for another in the next cycle.
- You may request a fee waiver as soon as you create an application, but keep in mind that fee waiver funds can be quickly depleted. Contact customer service at [617-612-2860](tel:617-612-2860) before you submit a fee waiver request to determine if waivers are still available.

Fee Waivers

Qualification Requirements

To qualify for a fee waiver, you must have either:

Filed a 2025 Federal Income Tax Return Form 1040 with an adjusted gross income that falls below the Low Income Level listed below, or

Been listed as a dependent on a filed 2025 Federal Income Tax Return Form 1040 with an adjusted gross income that falls below the Low Income Level listed below. **If you were claimed as a dependent by a parent or guardian on their 2025 Federal Income Tax Return, OTCAS requires you to use that individual's Federal Income Tax Return instead of your own.**

See an [example 1040 form](#) for reference and location of adjusted gross income. Note that you must submit both pages to OTCAS.

Additionally, you must request a fee waiver **before** you submit your application. Requests received after an application has been submitted will not be honored.

If you are approved for a fee waiver, you are required to submit your application within 14 days (including holidays and weekends). Extensions will not be granted; failure to submit your application on time will void your fee waiver and you will not be allowed to reapply for a waiver.

Program Selection

Before Selecting a Program

- **Check the program's deadline requirements.** Ensure you have enough time to apply. Determine if OTCAS or your program requires evaluations, transcripts, or other supplementary materials – if so, these must be received prior to the deadline for your application to be considered complete. Once your application is complete, it can take up to 10 business days to be verified.
- **Confirm your eligibility.** Research the program and determine if you are eligible to apply. Contact the program directly if you have any questions regarding your eligibility. We do not verify prerequisites and requirements. It is your responsibility to ensure you are eligible.
- **Confirm that the program still has seats available.** Some programs fill their classes prior to their posted deadline, even if they do not specifically state they offer rolling admissions. We strongly encourage you to contact your programs and ensure seats are still available before submitting your application. We cannot offer refunds if a school you selected has already filled its class, nor can we transfer the payment to another program.

Program Selection

Selecting a Program

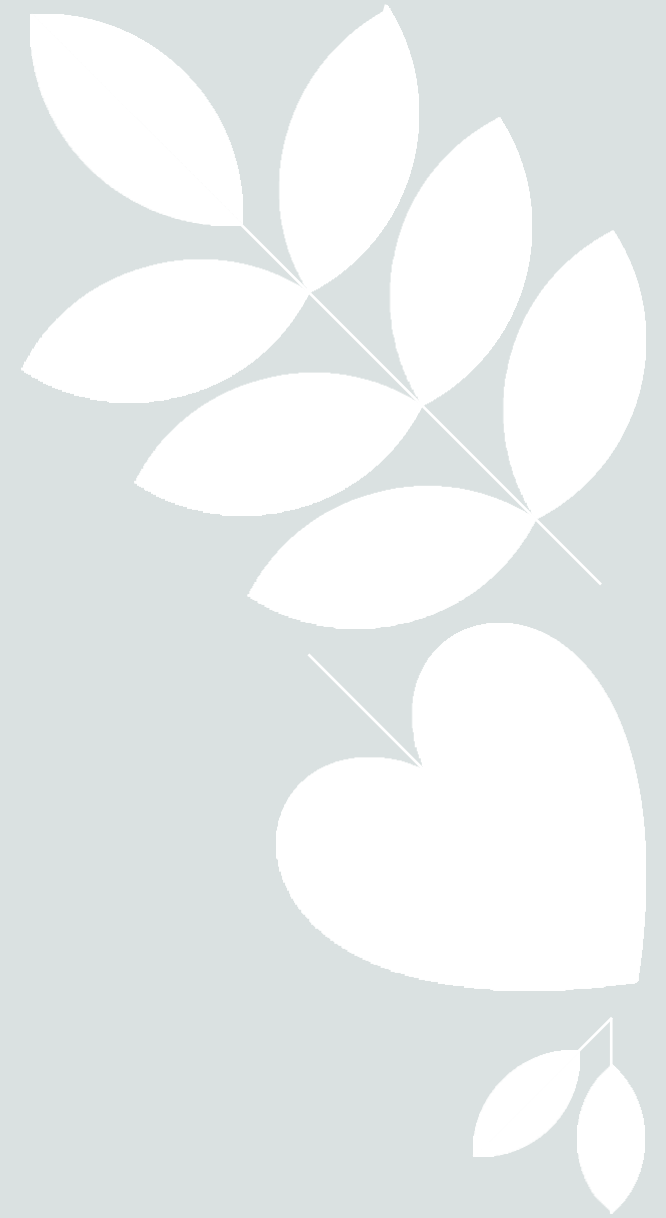
1. Click **Add Program** at the top of the application home page.
2. Use the filters to locate the programs you are interested in applying to.
3. Click the plus sign next to a program to add it to your program list. If you want to remove a program and only have one selected, you need to add the second program before you can remove the first one.
4. Continue adding programs as desired.
5. Begin filling out the application. Before submitting, be sure to review your program list to make sure you are applying to all your intended programs.
 - *Note that by submitting your application, you are committing to applying to your selected programs. You cannot substitute or remove submitted programs after submissions. Additionally, we do not offer refunds for selections made in error and we do not transfer payments to another program.*
 - *After submission, you can continue to add and apply to programs.*

Deleting Programs

- You can remove a program(s) at any time prior to submitting the application; however, any information entered in the **Program Materials** section will be lost and cannot be retrieved or transferred. Information in the **Personal Information, Academic History, and Supporting Information** sections will be retained for any programs to which you choose to submit.
- Once you submit your applications, you cannot remove any programs. To withdraw yourself from consideration for admission to a program, contact the program directly.
Note, however, that OTCAS does not offer applicant refunds for any reason.
- **Note that your application must always have at least one program selected. If you want to change or remove a program prior to submission, be sure to select a new program first.**
 - **From the Add Program Page**
 1. Click **Add Program** at the top of the page.
 2. Click the checkmark next to the program name.
 3. Click **Delete** to confirm.
 - **From the Submit Application Page**
 4. Click **Submit Application** at the top of the page.
 5. Click the trash can icon next to the program you want to remove.
 6. Click **Yes, Delete this Program**.

Personal Information

This section is used to gather your biographic and contact information, as well as citizenship, race/ethnicity, and other information.



Biographic Information

Your Name

- This section pulls in information you entered when you created your account. Confirm that what appears here is correct; click the **Profile Section** link to make changes.

Alternate Name

- If you are sending any documentation or test scores where your name is listed differently than it appears on your application, select **Yes** in this section and enter the alternate information. This ensures that your documents and test scores are matched to your application. Contact customer service so they can manually match these items to your application; failure to do so could cause significant delays.
 - Examples of alternate names include:
 - Birth names (if different from current legal name)
 - Maiden names
 - Nicknames (e.g., "Bob" for Robert, "Beth" for Elizabeth, etc.)
 - "Westernized" names
 - Alternate punctuation (e.g., your name appears with/without a hyphen, apostrophe, or diacritical marking)
 - Alternate spacing (e.g., your name appears with or without specific spaces)
 - Known misspellings (if a document contains a misspelling)

Biographic Information

Gender

- Select the appropriate option. This information is required for reporting purposes to the US Federal government, using these values only.

Birth Information

- Enter your date of birth in MM/DD/YYYY format. For example, January 7, 1989, would be listed as 01/07/1989. Make sure you enter your date of birth correctly; failure to do so could cause significant delays with matching documentation and test scores.
- Then, enter your country, city, state/territory/province, and county of birth. If you are unsure of your county of birth, select N/A.
- Note: to ensure applicants are entering consistent data for some questions, this application uses pre-populated answer options that are maintained by the International Organization for Standardization (ISO). For example, country answer options are derived from ISO 3166, which is the international standard for country codes and codes for their subdivisions.

United States Citizenship Details

- Select your US citizenship status and country of citizenship, if applicable. If you have dual citizenship, indicate your second country of citizenship.
- When selecting your status, consider the following definitions which are adapted from the US State Department:
 - **US Citizen:** an individual who was born in the US or attained citizenship through naturalization.
 - **Permanent US Resident:** an individual who holds a [Green Card](#) and is permitted to permanently live and work in the US.
 - **Temporary US Resident:** an individual who is an alien – a nonimmigrant foreign national – who is approved to temporarily live in the US for a specific purpose (e.g., as a student), has a permanent residence abroad, and does not hold a Green Card.
 - **Non-resident:** an individual who is a nonimmigrant foreign national and who is permitted to travel in the US for tourism or business for stays of 90 days or less.
 - **None:** an individual who has no US citizenship or visa (immigrant or nonimmigrant) status.
 - Note: to ensure applicants are entering consistent data for some questions, this application uses pre-populated answer options that are maintained by the [International Organization for Standardization \(ISO\)](#). For example, country answer options are derived from [ISO 3166](#), which is the international standard for country codes and codes for their subdivisions.

Residency Information

- Provide your residency information, including your legal state of residence.

Visa Information

- If you currently have a US Visa, select Yes and enter all visa information. Please note that we cannot advise you on your visa status or any related details.
- When selecting your visa type, consider the following definitions which are adapted from the US State Department. Note that this list is not all-inclusive. Refer to the US State Department for more information.
 - B-1 Visitor: an individual who wants to enter the US temporarily for business.
- F-1 Student: an individual who wants to study at a US academic institution. This is the most common student visa type.
- H1-B Employee: an individual who wants to work in the US in a specialty occupation.
- J-1 Student: an individual who wants to study at a US academic institution. This is generally used for students in educational exchange programs (e.g., Fulbright Program).
- J-1 Teacher, Researcher, or Trainee: an individual who wants to teach at a US primary or secondary school, research at a US institution, or train in an occupational field at a US business.
- Refugee: an individual who is located outside of the US, is of special humanitarian concern to the US, demonstrates that they were persecuted or fear persecution due to race, religion, nationality, political opinion, or membership in a particular social group, is not firmly resettled in another country, and is admissible to the US.
- Visa Waiver WB: an individual from a Visa Waiver Program (VWP) participating country that allows travel to the US for business stays of 90 days or less without obtaining a visa.
- Visa Waiver WT: an individual from a Visa Waiver Program (VWP) participating country that allows travel to the US for tourism stays of 90 days or less without obtaining a visa.
- Other: an individual who has received a visa type not listed. Note that this list is not all-inclusive and more visa types may be available in the application.

Contact Information

- Enter the address where you want to receive mail correspondence. Be sure to keep this section up-to-date as you complete and submit your application. If you anticipate a change of address, enter the date through which your current address is valid.
- Note: to ensure applicants are entering consistent data for some questions, this application uses pre-populated answer options that are maintained by the [International Organization for Standardization \(ISO\)](#). For example, country answer options are derived from [ISO 3166](#), which is the international standard for country codes and codes for their subdivisions.
- If you don't have a mailing address, you can list the address of a relative or friend, with their permission. If you find more permanent housing in the future, please update it in your application and with the programs you applied to.

Contact Information

Permanent Address

This is the address that will be used as your official, long-term residence. It may be used for residency verification or future correspondence. If you move, be sure to update this in OTCAS and notify your programs.

Phone

Enter a valid, active phone number where programs or OTCAS can reach you. Make sure your voicemail is set up and professional.

Email

Use an email address you check frequently. Be sure your spam/junk filters are adjusted to accept messages from OTCAS and programs. OTCAS and programs will send important updates, deadlines, and interview info here.

Race and Ethnicity

- Programs fully recognize the importance of diversity in their student body and in the workforce. Accordingly, programs strongly encourage applications from persons from all socioeconomic, racial, ethnic, religious, and educational backgrounds and persons from underrepresented groups. Please select any and all of the options in this section which you feel best apply to you. Please note that this section is used for statistical purposes only and in no way affects your application or financial aid eligibility.

Ethnicity

- Indicate whether you consider yourself to be of Hispanic or Latino origin. This question is optional.

Race

- Select one or more of the groups of which you consider yourself to be a member. This question is optional.

Other Information

Military Status

If you have US military experience, select your anticipated status at the time of enrollment from the drop-down. Select *Not a member of the military* if this does not apply.

Academic Infraction

Indicate whether you have ever been disciplined or placed on academic probation while attending an academic institution. If you select *Yes*, enter a brief explanation in the field provided.

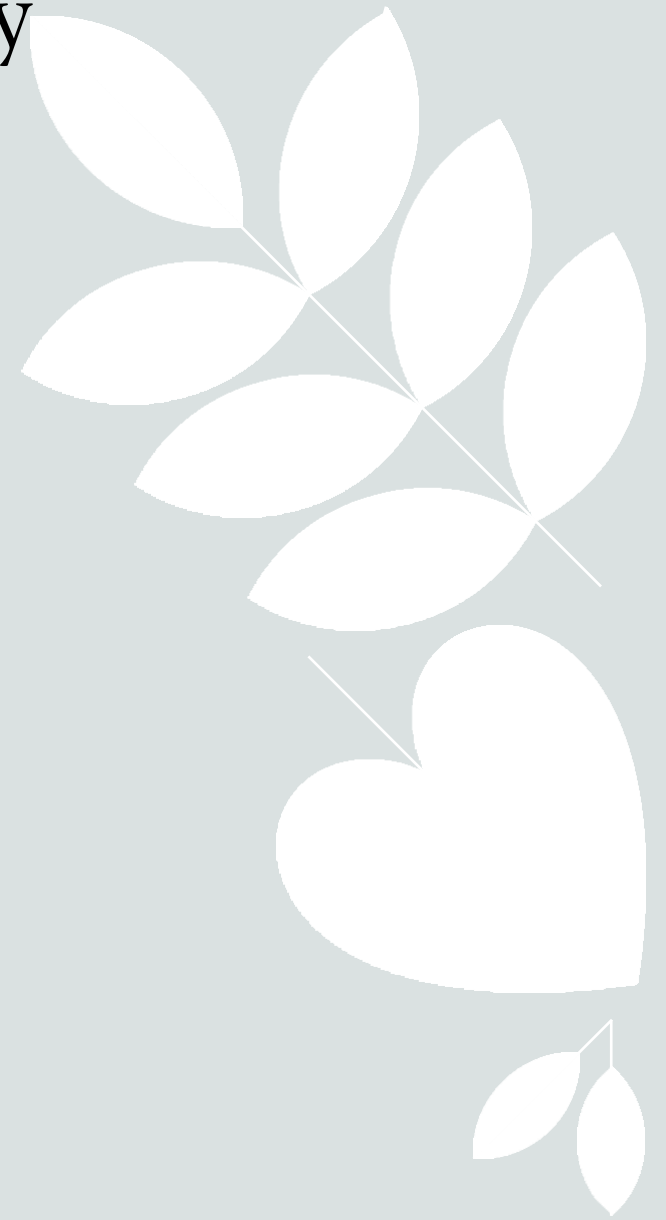

High School Attended

Follow the steps below to add your high school(s) to the application. Be sure to add each high school you attended individually.

1. Click **Add High School Attended**.
2. Enter your school's country, state, city, or zip code to narrow down your search.
3. Select your school from the list. If your school does not appear in the list, click **Add Unlisted High School** and manually enter the information.
4. Enter the dates attended by entering the month and year (e.g., May 2023).
5. Click **Save**.
6. Add more high schools, as needed. Then, click **I've added all of my high schools**.

Home Schools

Follow the steps below if you were home-schooled in high school.

1. Click **Add High School**.
2. Select **Home School**.
3. Use the **Country**, **State/Province**, and **City** drop-downs to enter the location of your home schooling.
4. Enter the name of your home school or associated school or organization.
5. Enter the dates attended by entering the month and year (e.g., May 2023).
6. Click **Save**.
7. Add more high schools as needed. Then, click **I've added all of my high schools**.

College Attended

Requirements

- **Report all institutions attended regardless of their relevance to the programs you are applying to.** Failure to report an institution may cause your application to be undelivered. This can significantly delay the processing of your application. Report all institutions attended, including but not limited to:
 - *courses taken in high school for college or university credit*
 - *summer courses*
 - *community college courses*
 - *US military academies (note that this does not include courses on SMART or JST transcripts)*
 - *post-baccalaureate, graduate, and doctoral work*
 - *study abroad, Canadian, and foreign work, etc.*
- **List all institutions on your application** even if the coursework completed there was transferred to another institution.
- **Report each institution only once**, regardless of the number of degrees earned or gaps in the dates of attendance.
 - **Send official transcripts** for each institution.

College Attended

Adding a College or University

1. Click **Add a College or University**.
2. Type and select your college or university. It may take several tries to find your school, especially if it shares its name with others or could be spelled differently. For example, if you attended "Saint John's University," you may need to try "Saint John," "St. John," or "St John" (no period) to bring the school up on the list. If you exhausted all options and it does not appear, select **Can't find your school?**
3. Select if you obtained (or plan to obtain) a degree from the selected institution.
 1. *If you earned or plan to earn a degree, provide details about the earned or expected degree.*
 2. *If you have a double major, select the checkbox to enter your second major. Note that you can only enter one minor.*
 3. Click **Add another Degree** to add additional degrees for this same college or university.
4. *Select your college's or university's term system. You can usually find this on the back of your official transcripts, or you can contact your college's registrar.*
 1. Term system refers to the type of hours your credits are worth, not the length of the term or how many terms a year your college or university offered.
 2. If your transcript lists some courses as quarter and others as semester, enter the term type that is most common (i.e., if you have six quarter terms and two semester terms, enter quarter).
5. *Select if you are still attending your institution. Enter dates of the first and last (if applicable) terms you attended. Be sure to only enter each college or university you attended once, regardless of gaps in your attendance there.*
6. Click **Save** to complete the entry.

Transcripts

To complete this section accurately:

- Report all courses on your transcripts. Be sure to include courses from which you withdrew, repeated courses, ungraded labs, test credits, gym courses, orientations, or other non-graded courses.
- Use official copies of your transcripts. List your courses under the correct term, year, and class level. Department prefixes and course numbers must precisely match those on your transcripts.
- Enter courses under the institution where you originally took the course, exactly as they appear on the original school's transcript.

Transcript Entry

Requirements

- Enter all the coursework you completed at all US and English Canadian colleges or universities attended. See **Foreign and French-Canadian Transcripts** and **Study Abroad or Overseas US Transcripts** for guidelines on foreign coursework. Note the following:
 - Reporting coursework accurately is your responsibility. Since credit values, grade values, and course subjects vary widely from school to school, your programs need some type of standardization so they can accurately compare applicants. This standardization is achieved by using your coursework to create a standard set of GPAs, ensuring you are compared to other applicants fairly and equally.
 - Complete the **Colleges Attended** section before entering your courses.
- Report all courses on your transcripts, not just prerequisites. Be sure to include courses from which you withdrew, repeated courses, ungraded labs, test credits, gym courses, orientations, or other non-graded courses.
- Use official copies of your transcripts. Coursework must exactly match your official transcripts; don't use an unofficial version, like a printout from your school's website. List your courses under the correct term, year, and class level. Department prefixes and course numbers must precisely match those on your transcripts.
- Enter courses under the institution where you originally took the course, exactly as they appear on the original school's transcript. Don't list courses under the school in which the credits were transferred. You may need to go back to your Colleges Attended and add a school to enter the transfer credits for.
- Note that if you don't want to enter all your coursework yourself, our specialists can enter it for you for an additional fee. See the **Professional Transcript Entry Service (PTE)** topic for more information.

Transcript Entry

Enter a Term

1. Click **Start** to begin entering courses for a college or university.
2. Add a semester, quarter, or trimester depending on the term system you selected in the **Colleges Attended** section.
3. Select a term.
4. Select a year. Options are based on the time spans you selected in the **Colleges Attended** section.
5. Select an academic status. Academic status refers to your status during the term you are inputting, not your current status. Refer to the list of Academic Status definitions below for more information.
6. Select a completion status. If you're entering courses for a term that is currently in progress or planned, select **In Progress/Planned**.
7. Click **Save**.
8. Continue adding terms, as needed.

Transcript Entry

Academic Status Definitions

- **Freshman-Senior:** Applies to all college- or university-level courses taken prior to your first bachelor's degree. In general, four-year students should list one year per designation and five-year students should list their last two years as senior. Non-traditional students should label their terms as evenly as possible in chronological order.
 - *Dual enrollment courses (college courses taken during high school) are considered Freshman and should be listed under the college where you took them. Do **not** report these courses again as transfer credits at your undergraduate institution.*
- **Post-Baccalaureate:** Applies to undergraduate level courses taken after your first bachelor's degree is earned. If you earned a second bachelor's degree, that is considered post- baccalaureate.
- **Graduate:** Applies to master's degree- and doctorate degree-level work only, regardless of whether the degree was earned. Work such as that taken in pursuit of a Ph.D, MD, PharmD, JD, JurisD, LL.D, DC., etc. are considered doctorate degree-level.

Transcript Entry: Entering Courses

Enter Courses for a Completed Term

1. Click **Add A Course** under the appropriate term.
2. Enter the course code. Department prefixes and course numbers must exactly match what appears on your official transcript.
3. Enter the course title. You can abbreviate it if it does not fit in the text box.
4. Select the course subject. If you're unsure, make your best guess; our team will help you if it doesn't match.
5. Enter the course credits exactly as they appear on your transcript. See the **Course Credits** section below for more details.
6. Enter the grade exactly as it appears on your transcript, including any pluses or minuses.
 1. *If your grades are listed as "BA," "CB," or "DC," you must list them as "AB," "BC," and "CD" in order for the system to recognize them.*
 2. *If your grades are listed as numbers (e.g., 93), enter them exactly as they appear on your transcript. They will automatically convert to the equivalent CAS letter grade.*
7. The **CAS Grade** populates automatically. This allows us to standardize your coursework for all programs and cannot be edited.
8. Click **Save**.
9. Continue adding courses, as needed.

Transcript Entry: Entering Courses

Enter Courses for an In-Progress or Planned Term

- You should enter any courses that you are currently taking or plan to take in the near future. This is not required, but is strongly recommended, as some programs require it. Note, however, that any term containing In Progress/Planned courses cannot be marked as complete; the entire term must be marked as In Progress/Planned. Contact your programs to determine if they require planned or in-progress coursework to be listed. Once you complete in-progress courses, you can update them in the application.
1. Make sure that you selected **In Progress/Planned** for the term you're listing the course under. This alerts the system that you aren't required to enter a grade for this course.
 2. Enter the course code.
 3. Enter the course title. You can abbreviate it if it does not fit in the text box.
 4. Select the course subject. If you're unsure, make your best guess.
 5. Enter the expected course credits. Depending on the format of your credits, you may need to convert them. See the **Course Credits** section below for more details.
 6. Click **Save**.
 7. Continue adding courses, as needed.

Transcript Entry: Narrative Transcripts

- If your institution uses a narrative transcript, enter your coursework as described above. If the transcript lists "suggested" credits and/or grades, be sure to enter those as well; otherwise, list the course credits as "0.0" and the grades as "Pass."
- Your programs will see the list of classes you took, along with a copy of the official narrative transcript that you submit.

Transcript Entry: Course Credits

Semester, Trimester, and Quarter Credits

- If your course credits are mostly in "3.0," "4.0," or "5.0" format, then your transcript is listing normal semester, trimester, or quarter credits and no conversion is necessary. Enter the credits exactly as they appear on your transcript.

Unit Credits

- If all of your course credits are listed in "1.0" or "0.50" format, then your transcript is listing credit units and you need to perform a conversion. Check the back of your transcript for a conversion ratio, which will say something like "1 unit is equivalent to 4 semester hours."
- If there is no conversion on the back of your transcript, contact your registrar's office to determine the conversion ratio. Then, convert the credits by multiplying the number of units listed on your transcript by the conversion factor. For example, if your conversion is 1 unit = 4 hours and your transcript lists 1 unit for a course, you would enter 4.00 credits on your application. If 0.50 is listed, you would enter 2.00.
- Review **OTCAS Grade Value Charts** to view some Canadian institutions' unit conversion ratios.

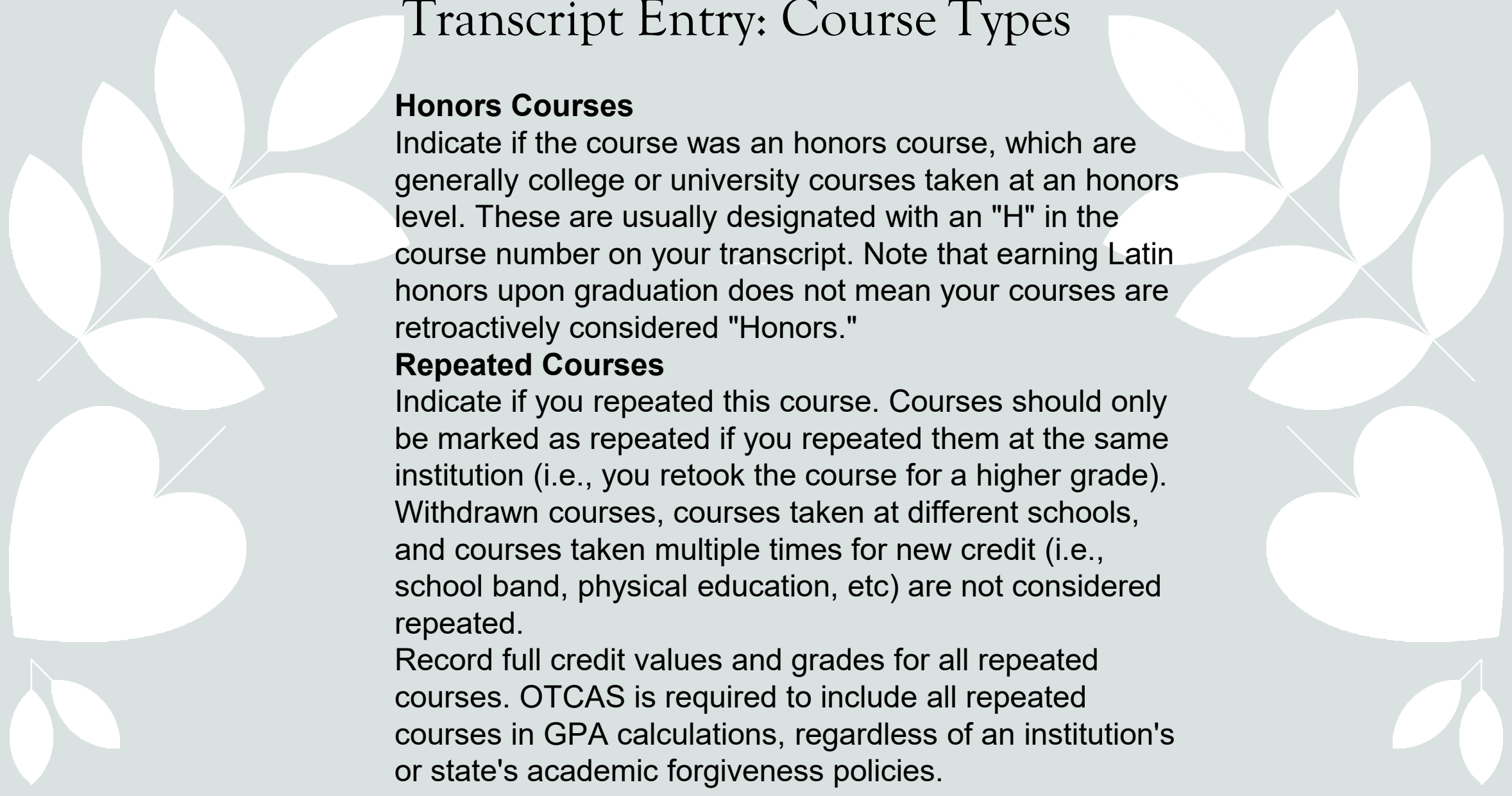
Transcript Entry: Course Credits

Lab Credits

- If your transcript lists labs separately, you must list them as separate courses on your application as well. Record the labs exactly as they appear on your transcript. If your transcript combines lab and lecture courses into one course, list it as one course on your application.

Test Credits

- You can only list test credits if they were awarded by one of the schools you attended, and they appear on your transcript. Test credit types include Advanced Placement (AP), International Baccalaureate (IB), CLEP, DANTE, Regents, and courses you "tested out of" at college or university. List these credits under your first term at the school that awarded you the credit and enter "CR" as the grade. If no course prefix or number appears on the transcript, enter "N/A" for Not Applicable.
- Be sure to designate these test credits appropriately in the Transcript Review section (below).



Transcript Entry: Course Types

Honors Courses

Indicate if the course was an honors course, which are generally college or university courses taken at an honors level. These are usually designated with an "H" in the course number on your transcript. Note that earning Latin honors upon graduation does not mean your courses are retroactively considered "Honors."

Repeated Courses

Indicate if you repeated this course. Courses should only be marked as repeated if you repeated them at the same institution (i.e., you retook the course for a higher grade). Withdrawn courses, courses taken at different schools, and courses taken multiple times for new credit (i.e., school band, physical education, etc) are not considered repeated.

Record full credit values and grades for all repeated courses. OTCAS is required to include all repeated courses in GPA calculations, regardless of an institution's or state's academic forgiveness policies.

Transcript Entry: Course Types

Advanced Placement Credit

Indicate if you received Advanced Placement (AP) credit on the College Board Advanced Placement Exams for this course. Be sure to only select this for courses that are clearly marked as AP on your transcript.

Other Test Credit

Indicate if you received credit for tests other than the AP exam, including International Baccalaureate (IB), CLEP, DANTE, Regents, or Institutional/Departmental exams (i.e., courses you "tested out of" at college or university). Be sure to only select this for courses that are clearly identified as test credits on your transcript.

Study Abroad Courses

Indicate if you took this course as a part of your institution's study abroad program. Refer to the **Sending Transcripts** section for more information.

Transcript Entry: Course Types

Course Credits

Semester, Trimester, and Quarter Credits

If your course credits are mostly in "3.0," "4.0," or "5.0" format, then your transcript is listing normal semester, trimester, or quarter credits and no conversion is necessary. Enter the credits exactly as they appear on your transcript.

Unit Credits

If all of your course credits are listed in "1.0" or "0.50" format, then your transcript is listing credit units and you need to perform a conversion. Check the back of your transcript for a conversion ratio, which will say something like "1 unit is equivalent to 4 semester hours."

If there is no conversion on the back of your transcript, contact your registrar's office to determine the conversion ratio. Then, convert the credits by multiplying the number of units listed on your transcript by the conversion factor. For example, if your conversion is 1 unit = 4 hours and your transcript lists 1 unit for a course, you would enter 4.00 credits on your application. If 0.50 is listed, you would enter 2.00.

Review **OTCAS Grade Value Charts** to view some Canadian institutions' unit conversion ratios.

Lab Credits

If your transcript lists labs separately, you must list them as separate courses on your application as well. Record the labs exactly as they appear on your transcript. If your transcript combines lab and lecture courses into one course, list it as one course on your application.

Test Credits

You can only list test credits if they were awarded by one of the schools you attended and they appear on your transcript. Test credit types include Advanced Placement (AP), International Baccalaureate (IB), CLEP, DANTE, Regents, and courses you "tested out of" at college or university. List these credits under your first term at the school that awarded you the credit and enter "CR" as the grade. If no course prefix or number appears on the transcript, enter "N/A" for Not Applicable.

Professional Transcript Entry Service

Overview

- If you prefer not to enter all your coursework yourself, the Professional Transcript Entry Service (PTE) specialists can enter it for you for an additional fee. This service is only available for completed coursework from accredited schools. Coursework from unlisted schools, foreign coursework, and planned/in-progress courses are ineligible for PTE and must be entered by you.
- Note that the PTE specialists only enter the information listed on your official transcripts and do not correct errors for coursework you have already entered. If you entered coursework and made a mistake or did not report an institution, these errors will be communicated to you during the verification process, at which point it will be your responsibility to correct them.
- Please refer to the **Refunding/Withdrawing Your Application** page for further payment policies.

Fees

- Fees for PTE are as follows:
 - 1-3 transcripts: \$80
 - 4-6 transcripts: \$110
 - 7 or more transcripts: \$150
- These fees apply only to coursework entry and are in addition to regular application fees. Fee waivers and coupon codes are not available for PTE. Additionally, your PTE payment cannot be transferred to another cycle (e.g., re-applicants, applicants applying in multiple cycles, etc.).

Professional Transcript Entry Service

1. Enter any coursework that is **not** eligible for PTE.

Before the PTE process can start, you must enter any coursework that is ineligible for PTE. Ineligible coursework includes planned or in-progress courses and courses taken at unlisted US schools. We cannot enter these courses on your behalf and they must be entered by you before you pay for PTE.

Note that once you make your PTE payment, you will be unable to enter any additional planned/in-progress courses until the verification process is complete.

2. Send us your official transcripts.

We must receive all required transcripts before PTE can begin. See **Sending Official Transcripts to OTCAS** for more details. Monitor your application to ensure your transcripts are received. On average, it takes up to five business days from the date we receive your transcripts to post them to your application. Once your transcripts post, you will receive a confirmation email and you can view your transcript receipt dates on the **Check Status** tab.

3. Sign up and pay for PTE.

Click **Tell Me More** at the bottom of the **Transcript Entry** page and follow the prompts to sign up for PTE and enter your payment information. Payments are non-refundable and can only be made online via credit card. After making your payment, you can continue adding colleges attended for PTE until you submit your application. You cannot add any colleges attended for PTE once your application is submitted or during the Academic Update period (if applicable).

4. Submit and complete your application.

Before PTE, you must submit and pay for your application. Once your application is submitted and we receive your transcripts, we will begin work on your application within 10 business days. Note that applications are placed in line for PTE on a first-come, first-served basis.



Professional Transcript Entry Service

Turnaround Time

- Once all the requirements are met, it may take up to 10 business days for transcript entry to be completed. Your application will not be given a Complete Date and moved into the verification queue until your coursework entry is approved, at which point it can take up to an additional 10 business days to be verified. Please keep these turnaround times and your program's deadline requirements in mind. We are not responsible for missed deadlines due to PTE procedures or turnaround times.

Professional Transcript Entry Service

Reviewing and Approving Your Coursework Entry

You will receive a notification once your PTE is complete. You should then review the coursework entered by the PTE specialists to ensure it is accurate and approve the entry.

Log in to your application and navigate to the **Academic History** section.

Click the **Transcript Entry** tab.

Review and approve the transcript information for each of your schools. If you find any issues with the coursework entry, email customer service to determine how to proceed. Wait for corrections to be confirmed and implemented before approving the coursework entry. If OTCAS allows you to determine whether a course is a lab or a lecture, please contact Customer Service and provide this information so they can identify the courses correctly on your behalf.

If applicable, match your courses to your program's prerequisites in the **Program Materials** section. Click **Assign Prerequisites** in the PTE Status section and follow the prompts. Once all of your prerequisites are matched, click **Finalize PTE Prerequisites** to return to the Transcript Entry page.

Once you approve your coursework entry (and complete all other application requirements), your application is given a Complete Date and placed in line for verification. Be sure to approve your coursework in a timely manner to avoid any delays in processing your application.

If you reapply in a future cycle, your PTE coursework will only carry forward if you submit your application and approve the PTE coursework entry in the current cycle.

Standardized Tests

Self-Reported Test Scores

- You can self-report your Standardized Test scores or report tests you plan to take in the **Standardized Tests** section. Some of the programs you apply to may require you to report certain test scores; be sure to check with your programs to ensure you are completing all requirements.
- Note that self-reporting your scores is not the same as providing official scores to your programs. If your programs require official test scores, see **Sending Official Test Scores** for more information.

- Complete the 9 prerequisite courses within the last 8 years, from an accredited college or university, with a grade of "C" or better, no later than June 1st of the admission year. Prerequisite GPA of 3.0 is preferred.
- GRE encouraged but not required: Prefer GRE score of 285 or greater and an analytical writing score of 3.5 or higher (**GRE Code: 4824**).

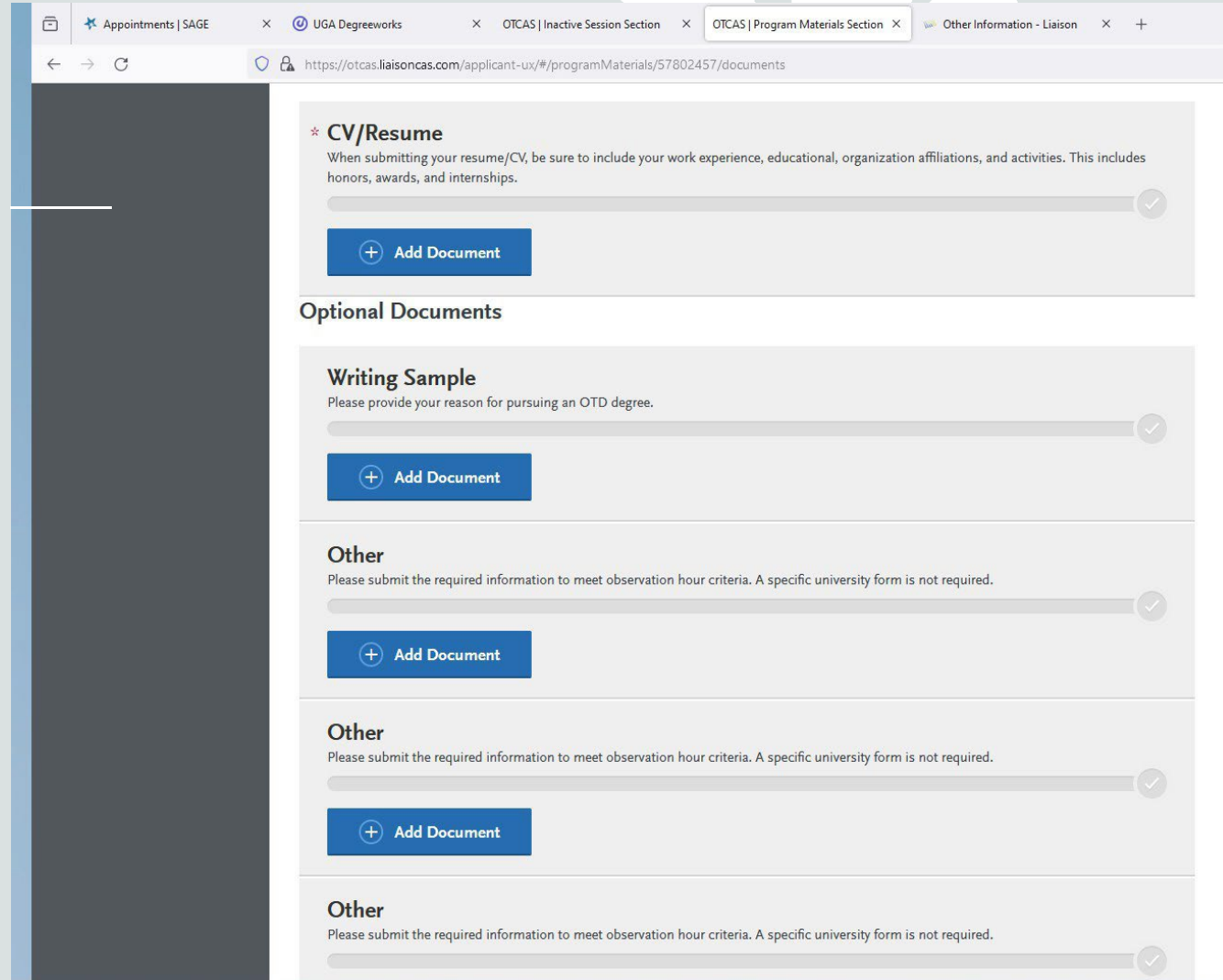

Program Materials: Documents

Documents

- The **Documents** tab is only available for certain programs. If applicable, you can upload documents that will only be visible to that particular program. Documents that do not have a red asterisk are optional and do not need to be uploaded for you to submit your application.
- Contact the program directly if you have any questions about their specific requirements.
- If your program provides a PDF form to fill out and upload in this section, you must save and upload it as an image. Depending on your computer's operating system, there may be multiple ways to do this; a Google search can point you in the right direction.
- Once your application is submitted, you cannot re-upload, update, or edit the documents in any way; however, you can upload new documents.

Please note that GSU OTD program does **NOT** accept AP (Advanced Placement) or CLEP (College Level Exam Progress) Credits as prerequisite courses.

Prerequisite courses include:

- 1.Human Anatomy and Physiology 1 with lab (3 credits)*
- 2.Human Anatomy and Physiology 2 with lab (3 credits)*
- 3.Human Growth and Development or Developmental Psychology (3 credits)
- 4.Abnormal Psychology (3 credits)
- 5.Statistics (3 credits)
- 6.Sociology or Anthropology (3 credits)
- 7.Medical Terminology (1-3 credits)

All prerequisite courses should be taken from a **regionally accredited college or university**. The GSU OTD program requires that **at least 3 out of the 7** prerequisite courses are completed AND 2 prerequisite courses are ongoing at the time of application submission. All prerequisites must be completed by the time of the anticipated start to the program in the following summer semester. **Human Anatomy and Physiology 1 with lab (3 credits) need to be completed at the time of the application submission**. All the prerequisites should be completed **within 7 years** from the time of the application submission.
