- Print your completed application for your records before submitting it to NursingCAS. Do not send the printed application via mail.
- Make sure to apply based on individual program deadlines.

Welcome Back

As a previous applicant to **NursingCAS**, you can speed up the application process by copying data from your previous application. Whether you submitted an application or started an application but did not complete the application process, this time saving process applies to you.

Confirm Your Profile Information



Step 1 in the re-applicant process is to confirm your profile information. Make any necessary updates to your Name, Contact Information and Account Information.

Decide if You Want to Copy Application Data



Step 2 in the re-applicant process is to decide if you want to copy data from a previous application. You will be able to review all of the application sections and decide what you want to copy. Or, you can start with a blank application to clear out all previous application information.

Choose Your Programs



Once you have updated your profile and decided which application data to copy, you will start your new application. The first step is selecting the programs to which you want to apply.

Review Application Sections



Every section of the application for which you choose to copy application data will initially be marked with the ! icon. You will need to visit each of these application sections to confirm the data is accurate or make updates.



Helpful Application Tips

- Do not enter your coursework from memory—Use your transcripts!
- Do not wait for nursingCAS to receive all materials before submitting your application.
- Do not wait for nursingCAS to receive all your materials before you submit your application.
- Complete the "Colleges Attended" section of the application first. Nursingcas cannot post transcripts to your application until this step is done.
- Consistently check status of your transcripts, references, test scores, and any forms.
- Arrange for all materials to arrive by the deadline.
- Check your email daily for important messages from nursingCAS and programs.
- Review your application for accuracy before submitting the application.



NursingCAS Timeline

6 WEEKS BEFORE

- Determine what programs might be a good fit
- Familiarize yourself with the requirements for each

5 WEEKS BEFORE

- Request transcripts if they are required
- Request references if they are required

4 WEEKS BEFORE

- Begin application
- Collect any required supporting materials, such as personal statements, documents, certification data, etc.

3 WEEKS BEFORE

- Follow up if transcripts haven't been received
- Continue working on your application

2 WEEKS BEFORE

- Finish and submit your application
- Congratulations! You're making good progress.

1 WEEK BEFORE

- Check your status online. (How?)
- Check your email about any outstanding items
- Confirm that transcripts and references have been received

Before Starting the NursingCAS Application:

Prior to applying you will want to research programs you wish to apply to.

Pay special attention to:

- Cycle dates and deadline requirements. In some instances, the individual program's deadline may differ from the application's cycle dates.
- Application fees. Some programs may have a supplemental fee; contact your programs to learn if they require this and how to pay it.
 - Evaluation requirements.
- Minimum requirements, including prerequisites, standardized test scores, supplemental applications, foreign evaluations, etc.

A Note about Etiquette

NursingCAS expects all applicants to exhibit professionalism when contacting customer service.

Applicants must identify themselves properly and honestly, as information cannot be provided to parents, spouses, family members, or friends. Misrepresentation of identity and/or dishonest, threatening, or offensive communication will not be tolerated.

NursingCAS Background Checks

Overview

Background checks vary widely from program to program. Some programs require applicant background checks prior to acceptance, while others require these checks as a condition of matriculation. For questions about background checks – including when in the application process this must be completed – contact each of your programs directly.

Background checks reflect all prior convictions, guilty pleas, city ordinance citations (such as public intoxication), illegal possession(s) including possession of alcohol under the legal age, payments of fines (including those for traffic violations), and in some cases, prior records thought to have been expunged. Note that in some states, common traffic violations can be considered misdemeanors.

Programs that Require Background Checks

Programs that require a background check will often initiate this process after you have submitted your application; they use a vendor such as [Castle Branch](#) (note: you should contact your programs directly for specific details). Each program that uses Castle Branch will send you an email with instructions on how to complete your background check.

If you are using Castle Branch and need assistance, it may be helpful to contact their [customer service](#).

Fees & Fee Waivers

Fees

NursingCAS charges the following application fees:

Undergraduate Programs

\$70 for the first undergraduate-level program and \$55 for each additional program.

Graduate Programs

\$90 for the first graduate-level program and \$60 for each additional program.

2026-2027 Fee Assistance Program

Beginning at the start of the cycle, a limited number of fee waivers are provided to qualified applicants on a first-come, first-served basis. Each fee waiver covers only the initial application fee, so if you wish to apply to additional programs, you are responsible for the remaining balance. If you received a fee waiver during a previous cycle, you may still apply for another in the next cycle.

You may request a fee waiver as soon as you create an application, but keep in mind that fee waiver funds can be quickly depleted. Contact customer service at [617-612-2880](tel:617-612-2880) before you submit a fee waiver request to determine if waivers are still available.



Fee Waiver Qualification Requirements:

There are two types of fee waivers applicants can qualify for:

- Income-based
- Service-based

You can only apply for one type of fee waiver per cycle. Additionally, you must request a fee waiver before you submit your application. Requests received after an application has been submitted will not be honored.

If you are approved for a fee waiver, you are required to submit your application within 30 days (including holidays and weekends). Extensions will not be granted; failure to submit your application on time will void your fee waiver and you will not be allowed to reapply for a waiver.

Financial Based Fee Waiver

To qualify for an income-based fee waiver, you must have either:

- Filed a **2025 Federal Income Tax Return Form 1040** with an adjusted gross income that falls below the Low-Income Level listed below, or
- Been listed as a dependent on a filed **2025 Federal Income Tax Return Form 1040** with an adjusted gross income that falls below the Low-Income Level listed below. If you were claimed as a dependent by a parent or guardian on their **2025 Federal Income Tax Return**, NursingCAS requires you to use that individual's Federal Income Tax Return instead of your own.

Service-Based Fee Waiver

To qualify for a service-based fee waiver, you must have participated in one of the eligible service-based organizations:

- [Active AmeriCorps Volunteer](#)
- [McNair Scholar](#)
- [Peace Corps In-Country Volunteer or Alumni](#)

Click on the organization above to download the fee waiver form. Complete the form, and if necessary, also have a certifying officer or program administrator complete their section of the form.

Start your application.

You must have an account to apply for a fee waiver. Fee assistance applications are not accepted by mail or email.

Complete and submit your fee assistance application.

1. Click on your name in the upper right corner of the application, then select **Fee Assistance Program**.
2. Select the type of fee waiver you want to apply for.
 - If selecting financial-based fee waiver, enter your household's adjusted gross income for 2020 and the current number of members in your household. Note that "size of family" includes the number of people claimed as dependents on the tax report. Then upload a copy of the filed 2020 Federal Income Tax Return Form 1040 or 1040A. This form was either filed by you or by someone who listed you as a dependent (such as a parent or guardian). Remember, if you were listed as a dependent, you must submit that individual's tax return form instead of your own.
 - If selecting service based fee waiver, upload official documentation showing proof of service, such as:
 - Confirmation of attendance
 - Form with a certifying signature
 - Certificate of completion, etc.

Await notification.

Once you submit your fee waiver request, it can take up to 10 business days to process. The status of your request will be sent to both your email address and your application inbox.

While your fee waiver request is pending, you are unable to submit your application. To submit your application and forfeit your waiver request, return to the **Fee Assistance Program** section and click **Cancel Request**. Once you submit your application, you are ineligible to apply for another fee waiver.

Submit your application and pay any remaining balance.

If you are approved, you will receive a coupon code to redeem your fee waiver amount of \$55 (undergraduate programs) or \$75 (graduate programs). You are responsible for any remaining balance. You can apply your coupon code when you are ready to submit your application.

1. Click the **Submit Application** tab at the top of the application.
2. Click **Submit**, or to submit to more than one program, click **Submit All**.
3. On the payment page, enter the fee waiver coupon code under **Apply Coupon**.
4. Click the **Apply Coupon** button.

Coupon Codes

Some programs provide coupons that offset application fees. If you received a coupon code from your program, use the information below to apply it to your payment.

Note that coupon codes cannot be redeemed after an application has been submitted. Additionally, if you miss a program deadline due to waiting for a coupon code, you must request a deadline extension from your program, not NursingCAS.

Using a Coupon Code

You can apply your coupon code(s) when you are ready to submit your application.

1. Click the **Submit Application** tab at the top of the application.
2. Click **Submit**, or to submit to more than one program, click **Submit All**.
3. On the payment page, enter the coupon code(s) you received from the program(s) under **Apply Coupon**.
4. Click the **Apply Coupon** button.
5. Complete the rest of the payment details pages.

Note the following:

- When a coupon code equals the total transaction amount, you don't need to enter additional payment information.
- When a coupon code is less than the total transaction amount, you'll need to enter payment information for the additional balance.
- When a coupon code is more than the total transaction amount, you don't need to enter additional payment information. However, you'll forfeit the remaining balance offered by the coupon code, as NursingCAS will not issue credits or carry remaining balances forward.
- Coupon codes cannot be applied to chargeback fees.

If you used a coupon code when submitting to a program, the code will be listed under **Payment History**.

Account Creation

- To begin, click the “Create an Account” button on the NursingCAS application homepage. Enter a username, password, security question, and valid contact information. Click on the “Create My Account” button to activate a new account and unique NursingCAS identification number. You are not permitted to create more than 1 NursingCAS account per application cycle! Duplicate accounts will result in significant processing delays and problems with application materials! NursingCAS will delete duplicate accounts, including associated documents!



Account Creation

Note: there is no cost for account creation; applicants are not charged until they select programs and submit their application.

When creating an account, You will be prompted to submit the following information: Name, Contact Information, Username and Password, Agreement of Terms of Service.

Add A Program

1. Click **Add Program** at the top of the application home page.
2. Use the filters to locate the programs you are interested in applying to.
3. Click the plus sign next to a program to add it to your program list. If you want to remove a program and only have one selected, you need to add the second program before you can remove the first one.
4. Continue adding programs as desired.
5. Begin filling out the application. Before submitting, be sure to review your program list to make sure you are applying to all your intended programs.

Note that by submitting your application, you are committing to applying to your selected programs. You cannot substitute or remove submitted programs after submissions. Additionally, we do not offer refunds for selections made in error and we do not transfer payments to another program.

After submission, you can continue to add and apply to programs until the final deadline date.

Each school and program is able to collect additional information from applicants if more information is needed for their applicant review process. This statement serves as a contractual agreement between you and NursingCAS. You must agree to these terms in order to submit your application.

- I understand that I am responsible for learning the admission requirements, application policies, and due dates for each school to which I am applying and that I am not eligible for a refund of NursingCAS fees if I do not meet the admission requirements of the nursing schools to which I apply.
- I understand that I am responsible for researching the accreditation status of each program to which I am applying. I understand that attending an unaccredited nursing program may have implications on my eligibility for federal student aid, completing clinical requirements, ability to sit for licensure exams, and more.

Advisor Release

Selecting **Yes** for this release allows NursingCAS to release certain information to health profession advisors and health profession advisory committees at schools you previously attended. This information includes some application information, including your GPA, the names of the nursing programs to which you applied, and which program, if any, you matriculate into. They will not see documentation such as transcripts or letters of reference.

If you select **No**, NursingCAS will not release your information to advisors. We encourage you to authorize this release, as it is useful to advisors assisting you and other future applicants; however, it will not affect the consideration given to your application.

Alternate Name

[ACADEMIC RECORDS](#)

Adding a College or University

1. Click **Add a College or University**.
2. Type and select your college or university. It may take several tries to find your school, especially if it shares its name with others or could be spelled differently. For example, if you attended "Saint John's University," you may need to try "Saint John," "St. John," or "St John" (no period) to bring the school up on the list. If you exhausted all options and it does not appear, select **Can't find your school?**
3. Select if you obtained (or plan to obtain) a degree from the selected institution.
 1. If you earned or plan to earn a degree, provide details about the earned or expected degree.
 2. If you have a double major, select the checkbox to enter your second major. Note that you can only enter one minor.
 3. Click **Add another Degree** to add additional degrees for this same college or university.
4. Select your college's or university's term system. You can usually find this on the back of your official transcripts, or you can contact your college's registrar.
 1. Term system refers to the type of hours your credits are worth, not the length of the term or how many terms a year your college or university offered.
 2. If your transcript lists some courses as quarter and others as semester, enter the term type that is most common (i.e., if you have six quarter terms and two semester terms, enter quarter).
5. Select if you are still attending your institution. Enter dates of the first and last (if applicable) terms you attended. Be sure to only enter each college or university you attended once, regardless of gaps in your attendance there.
6. Click **Save** to complete the entry.

If Your Program Requires Full Transcript Entry:

Enter all the coursework you completed at all US and English Canadian colleges, or universities attended. See **Foreign and French-Canadian Transcripts** and **Study Abroad or Overseas US Transcripts** for guidelines on foreign coursework. Note the following:

- Reporting coursework accurately is your responsibility. Since credit values, grade values, and course subjects vary widely from school to school, your programs need some type of standardization so they can accurately compare applicants. This standardization is achieved by using your coursework to create a standard set of GPAs, ensuring you are compared to other applicants fairly and equally.
- Complete the **Colleges Attended** section before entering your courses.
- Report all courses on your transcripts, not just prerequisites. Be sure to include courses from which you withdrew, repeated courses, ungraded labs, test credits, gym courses, orientations or other non-graded courses.
- Use official copies of your transcripts. Coursework must exactly match your official transcripts; don't use an unofficial version, like a printout from your school's website. List your courses under the correct term, year, and class level. Department prefixes and course numbers must precisely match those on your transcripts.
- Enter courses under the institution where you originally took the course, exactly as they appear on the original school's transcript. Don't list courses under the school in which the credits were transferred. You may need to go back to your Colleges Attended and add a school to enter the transfer credits for.
- NursingCAS will verify your coursework entry for accuracy, and your application will be returned to you if there are any inconsistencies, which may result in delays in submitting your application.

If Your Program Requires Transcript Entry for Prerequisites Only:

Entering prerequisite coursework is a 3-step process:

1. Visit the **Program Materials** section of your application to review each program's prerequisite coursework requirements. Programs that require prerequisites will have a **Prerequisites** tab where you can view this information.
2. Once you are familiar with the requirements, navigate to the **Transcript Entry** section and enter only the specific courses you have completed which match each program's prerequisite coursework requirements.

Professional Transcript Entry Service (PTE)

Overview

If you prefer not to enter all your coursework yourself, the Professional Transcript Entry Service (PTE) specialists can enter it for you for an additional fee. This service is only available for completed coursework from accredited schools. Coursework from unlisted schools, foreign coursework, and planned/in-progress courses are ineligible for PTE and must be entered by you.

Note that the PTE specialists only enter the information listed on your official transcripts and do not correct errors for coursework you have already entered. If you entered coursework and made a mistake or did not report an institution, these errors will be communicated to you during the verification process, at which point it will be your responsibility to correct them. Please refer to the **Refunding/Withdrawing Your Application** page for further payment policies.

Fees

Fees for PTE are as follows:

- 1-3 transcripts: \$80
- 4-6 transcripts: \$110
- 7 or more transcripts: \$150

These fees apply only to coursework entry and are in addition to regular application fees. Fee waivers and coupon codes are not available for PTE. Additionally, your PTE payment cannot be transferred to another cycle (e.g., re-applicants, applicants applying in multiple cycles, etc.).

Process

Turnaround Time

Once all the requirements are met, it may take up to 10 business days for transcript entry to be completed. Your application will not be given a Complete Date and moved into the verification queue until your coursework entry is approved, at which point it can take up to an additional 10 business days to be verified. Please keep these turnaround times and your program's deadline requirements in mind. We are not responsible for missed deadlines due to PTE procedures or turnaround times.

Reviewing and Approving Your Coursework Entry

You will receive a notification once your PTE is complete. You should then review the coursework entered by the PTE specialists to ensure it is accurate and approve the entry. You should also match your coursework to any required prerequisite courses in the **Program Materials** section before approving the entry.

If you find any issues with the coursework entry, email customer service to determine how to proceed. Wait for corrections to be confirmed and implemented before approving the coursework entry.

Once you approve your coursework entry (and complete all other application requirements), your application is given a Complete Date and placed in line for verification. Be sure to approve your coursework in a timely manner to avoid any delays in processing your application.

If you reapply in a future cycle, your PTE coursework will only carry forward if you submit your application and approve the PTE coursework entry in the current cycle.

PTE, complete the following required steps:

Work that is not eligible for PTE.

Before the PTE process can start, you must enter any coursework that is ineligible for PTE. It includes planned or in-progress courses and courses taken at unlisted US schools. We cannot enter them and they must be entered by you before you pay for PTE.

Note that once you make your PTE payment, you will be unable to enter any additional planned coursework until the verification process is complete.

Official transcripts.

We must receive all required transcripts before PTE can begin. See **Sending Official Transcripts** for details. Monitor your application to ensure your transcripts are received. On average, it takes 10 business days from the date we receive your transcripts to post them to your application. Once your transcripts are received, you will receive a confirmation email and you can view your transcript receipt dates on the **Check Status** tab.

Click **Tell Me More** at the bottom of the **Transcript Entry** page and follow the prompts to sign up for PTE. Payments are non-refundable and can only be made online via credit card. After payment, you can continue adding colleges attended for PTE until you submit your application. Complete your application.

Before PTE, you must submit and pay for your application. Once your application is submitted and payment is received, we will begin work on your application within 10 business days. Note that applications are processed on a first-come, first-served basis.



Standardized Tests

You can self-report your Standardized Test scores or report tests you plan to take in the **Standardized Tests** section. Some of the programs you apply to may require you to report certain test scores; be sure to check with your programs to ensure you are completing all requirements.

References (sometimes called Letters of Evaluation, Letters of Reference, or Letters of Recommendation) are submitted by the references themselves; they cannot be completed or submitted by the applicant or another party on behalf of the reference. We are not responsible for verifying references' identities. If a discrepancy is found, we reserve the right to contact the appropriate individuals to investigate and to share the discrepancy with all programs.

Before getting started, consider the following:

- **All references are submitted electronically** by references using [Letters by Liaison](#), our Recommender Portal.
- **Research each program's requirements.** You should determine whether your programs have specific requirements regarding reference roles or relationships before listing references on your application. Many programs have strict guidelines and completed references cannot be removed or replaced.
- **Choose your references early in the application process** to ensure they have adequate time to submit your reference.
- **Prepare your references.** Once you choose your references, be sure to inform them about the process and that they will be completing the reference electronically. We recommend getting their preferred email address and asking that they monitor that inbox for your reference request (which will come from nursingcasinfo@nursingcas.org), including any junk or spam folders.

The Reference Process

When you request references, your reference receives an email request with a link to Letters by Liaison. References review your requests, and then accept, complete, or deny them. References may complete assessments such as writing essays, completing Likert scales, and/or uploading letters. Once your reference completes your reference, you'll be notified via email. You can check the status of your reference requests in the **Check Status** tab of your application at any time.

Submitting a Reference Request

1. On the **References** tab, click **Add Reference**.
2. Enter the reference's full name and email address.
3. Select the date by which you would like this reference completed. This date should be before your program(s) deadline.
4. Enter a brief message or note for the reference.
5. Select whether you want to waive your right of access to the reference. See **Waiver** below.
6. Click the checkboxes to indicate your permission for us (and programs) to contact your references.
7. Click **Save This Reference Request** to submit it. Once you do so, an email is immediately sent to the reference.
8. Confirm with your references that they received the email notification.
9. Use the **Check Status** tab to monitor the status of your references. Completed references are marked as "Complete" and have a Complete Date listed. Follow up with your references if their references are still marked as "Requested" or "Accepted." It is your responsibility to ensure that reference requests are received and completed on time. We will not notify applicants about missing references.

Waiving References

The Family Education Rights and Privacy Act of 1974 (FERPA) gives you the right to access references unless you choose to waive your right of inspection and review. Prior to requesting any references, you are required to indicate whether you wish to waive your rights. NursingCAS will release your decision to waive or not waive access to your references and designated programs. Your waiver decision serves the same purpose as a legal signature and is binding.

Selecting **Yes** indicates to programs that your reference completed their reference with the understanding that you would not be able to view it. This means you will not be able to see the content of the reference. Programs may view this type of reference as a more accurate representation of an applicant's qualifications.

Selecting **No** indicates to programs that your reference completed their reference with the understanding that you may choose to view it in the future. Selecting this option does not allow you to view your reference via the application. If you do not waive your right to view the reference, you may ask your reference for a copy of the reference. Programs may view this type of reference as a less accurate representation of an applicant's qualifications.

Once you make a selection, you can't change it, so consider the choices carefully.

Kira Assessment

Some programs may request or require that you complete a Kira Talent assessment, which is separate from your NursingCAS application. Kira Talent is a cloud-based, online video screening platform where your programs create virtual interview questions. Contact each program directly if you have questions.

To submit a Kira assessment:

1. Click **Open Kira Assessment**.
2. You will then be redirected to Kira Talent, where you can register and complete your assessment.

Once you complete the Kira assessment, return to your NursingCAS application to verify that the section is marked complete. It can take up to one hour to update, and you may need to refresh the page.

While I cannot guarantee schools will use the same essay topics as last year, I can tell you the topics of previous years in case you want to have a foundation/get a head start.

- Explain the academic challenges, obstacles, or successes, in your life that impacted your ability to achieve your goals.
- *can look through the documents tab to see if you want to add any of the optional docs

Augusta CNL😊

- Why are you pursuing a career in nursing? (2500 characters)
- Referring to the American Association of Colleges of Nurse Competencies and Curricular Expectations for CNL Education & Practice (2013)., please summarize your understanding of the CNL role. Using specific examples, please elaborate on how your experiences will make you a strong clinical nurse leader given your understanding of this role. (2500)
- Maturity, intellectual curiosity & integrity are attributes we value in the CNL program. Please briefly and using specific examples, address how you embody each of these characteristics. (2500)
- The MSN-CNL program with AU is an intensive, accelerated program. What challenges do you anticipate during nursing school? (2500)
- Describe a time when you demonstrated leadership skills without the formal title of leader? (2500)
- Explain any academic challenges, successes, or obstacles in your academic journey that impacted your ability to achieve your goals. (8000)
- *Don't forget to add CV/RESUME in the required documents tab

Statement of Purpose Tips

Keep your topic general: keep the statement general as this essay is sent to all the programs you apply to. If you plan to only apply to one program, we still strongly recommend keeping your statement general in case you later apply to additional programs. Once you submit your application, the essay cannot be edited or changed.

- **Do not exceed the maximum length:** you can see both the word and character count below the field in the application. The right-hand number shows the maximum number of characters that you can use in your essay. As you type, you can see how many characters are still available and the associated word count. Characters include spaces, carriage returns, and punctuation. You cannot save your essay if it exceeds the 4,500 character limit.

- **Use your own words:** plagiarizing any part of your essay is a violation of the code of conduct and may subject you to sanctions.

- **Use simple formatting:** formatting such as tabs, italics, multiple spaces, etc., will not be saved. To delineate paragraphs, type a double return between each paragraph.

Be sure to read over your essay several times to catch any spelling, grammar, punctuation, etc., errors before submitting. Once you submit your application, you cannot edit your essay. If you find an error after submission that you believe could have major effects on your application, we recommend sending a corrected copy directly to the programs you applied to.
